This seminar is the concluding action of the **DireDate** project, launched by Eurostat with the aim of identifying "Direct and indirect data needs linked to the farms for agri-environmental indicators". DireDate is carried out by a research consortium led by Alterra Wageningen UR (NL), with the University of Aarhus (DK), Institute of Technology and Life Sciences, ITP/IMUZ (PL), University of Natural Resources and Applied Life Sciences (AT) and ADAS (UK) as partners.

This project is now drawing to an end, and Eurostat organises the final seminar on 28 March 2011 in Luxembourg in order to report the results and recommendations of the project to stakeholders and other interested parties. These include statistical offices, policy makers, international organisations like OECD and FAO, farmers' associations, agricultural and environmental research centres and partners in the European Commission (Directorates-General for Agriculture and Rural Development, Environment, Climate Action, and the Joint Research Centre) and the European Environmental Agency (EEA).

Eurostat strongly believes that invitees will greatly benefit from the results of this project, as it will clarify how to set up data flows from the farm level in order to improve both the quality and availability of statistics, indicators and other data on agriculture and environment. This is why I would like to invite you to the seminar, to show how important it is to progress in this domain together.

Project rationale

Eurostat coordinates the work within the European Commission and with the EEA on the 28 Agrienvironmental indicators (AEI) that were identified in the <u>Commission Communication COM(2006) 508</u> and subsequently approved by the Agricultural Council. We noted that while on the one hand not all data needed to provide the AEI are currently available, there are on the other hand several parallel data flows containing or using the same or almost the same information. Such flows are for instance the agricultural parts of greenhouse gas and ammonia emissions, as well as some of the indicators used for monitoring the Rural Development Programmes and Water Framework Directive. This suggests that there might be opportunities for a more efficient data collection, which would not only benefit AEI but also other policy requirements.

In order to facilitate setting up a sustainable system for collecting the data needed for analysing the relations between agriculture and the environment, Eurostat launched the DireDate project which aims at both identifying the direct and indirect data that should be provided at farm level and are needed not only for the AEI but also for closely related policies, and at ensuring efficiency and coherence with other reporting requirements. The data collection to be set up will serve European and national statisticians and policy makers, as well as agricultural and environmental researchers, observers of climate change and other environmental issues linked to agriculture.
